Examples of expectations include deposits and withdrawals throughout the statement cycle, such as direct deposit of paychecks or Social Security checks, etc., along with POS debit transactions throughout the month of varying amounts at various retailers. This does not include transactions such as multiple small-dollar POS transactions at the end of the statement cycle in order to earn the higher APY, which would not be consistent with the design of the account. \$100 minimum opening deposit. No minimum balance required. No monthly service charge. Must be a Yuma County resident to open this account.
